- Incorporating the environmental management system into our business strategy and business processes, thus identifying our environmental risks and opportunities and taking measures to minimize the risks we identify,
- To follow technologies, research and global developments related to the effective management of environmental protection and to ensure the creation of necessary resources in this context,
- To be sensitive to the environment and to ensure that this sensitivity is widespread by raising the awareness of our employees through training on environmental and climate change issues,
- To control the environmental impacts arising from our Storage, Heating, Cleaning, Maintenance, and Repair to eliminate these impacts or to work to reduce them if they cannot be eliminated,
- Ensuring effective use of natural resources,
- To take environmental protection and pollution prevention as a basis when planning our activities,
- To evaluate new investments, acquisitions or mergers by taking environmental impacts into consideration, and to establish facilities in forested areas with high carbon stock without causing destruction or resource pollution,
- To implement and follow Alışan Den Hartogh A.Ş.'s priority sustainability issues in all business activities,
- In all our activities, we aim to prevent waste generation through efficient use of resources, work to reduce unavoidable waste, define hazardous and non-hazardous waste within the scope of legal regulations and zero waste practices, collect them at source with appropriate equipment and methods, ensure that they are kept in temporary storage areas, evaluate those suitable for reuse, make the necessary organization for the recovery of those suitable for recovery, and provide recycling and disposal processes as a last resort,

- To determine air emission sources and to have emission measurements carried out regularly in order to prevent pollution,
- To provide training to our employees, suppliers, interested parties and customers regarding the environmental impacts of our business activities,
- To act by taking into account the health and safety of our customers, to raise awareness among all our customers on this issue, to prevent possible dangers by taking the necessary precautions in advance with a risk-based perspective,
- To ensure environmental management during the storage and transportation of all kinds of chemicals, to store and transport chemicals in a way that will not harm the environment, and to take the necessary precautions to prevent leaks and spills that may occur during our activities from mixing with groundwater,
- To reduce greenhouse gas emissions (scope 1 and 2) by 50% by 2030 compared to the determined base year and to regularly monitor and report greenhouse gas emissions,
- To reduce the amount of water consumed within the scope of our activities and to try to minimize wastewater generation, to identify water-related risks in the geographies where we operate and manage these risks effectively, and to ensure compliance with legal requirements regarding the water supplied, used, and discharged.
- To improve the quality of water emissions resulting from our activities,
- Ensuring our employees have access to clean and safe water,
- To examine and evaluate the proximity of Alişan Den Hartogh A.Ş.'s existing and newly included facilities to areas with significant biodiversity, to include this evaluation in decision-making processes, to work to prevent or minimize the factors that threaten biodiversity in these regions, to integrate biodiversity into Alişan's environmental management system, to give importance to identifying risks and opportunities regarding ecosystems and biodiversity, and to protect ecosystems and biodiversity through action plans to be implemented,
- Focusing on energy efficiency in all our business processes, prioritizing environmental protection and energy efficiency in future planned investments and activities, and turning to renewable energy sources,
- We undertake to continuously monitor our environmental performance in line with the environmental performance criteria we have determined and to share it with all relevant parties through the published sustainability report.

All members of our organization, without exception, aim to manage and carry out all our processes in the best way possible by adhering to these conditions and always cooperating with our customers and suppliers. As Alişan Lojistik AŞ, we aim to keep our commitments to the quality, environment, safety and health management systems that we have established for these purposes open to public access with this policy for the access of all interested parties.
